## UIoBR Waiver and Indemnity Agreement

I hereby agree to the following provisions waiving all liability as against Urban Impact of Black Rock know as "UIoBR", its officers and directors, and all employees, volunteers, agents, and departments of UIoBR including but not limited to (UIoBR) Office of Chairman – (UIoBR) Vice Chairman – (UIoBR) Secretary – (UIoBR) Treasurer – (UIoBR) Managing Partner, etc., and agreeing to indemnify and hold the UIoBR (including its officers, directors, employees, volunteers and agents), absolutely harmless under the circumstances described below:

1. I have applied for and been accepted to participate a program organized by Urban Impact of Black Rock to participate in a Christian Missionary and humanitarian Venture.
2. I represent to UIoBR that I have undertaken all necessary preparations in order to participate in the Venture, including any physical examination by a physician that I deem necessary and obtaining all immunizations that are required or that I desire. I further represent to UIoBR that I am healthy, in good physical condition, and able to undertake this Venture safely.
3. I acknowledge that this Venture involves many substantial risks to my health and safety as well as the safety of my property and personal belongings. These risks include, but are not limited to, risks to personal belongings, and accident of delay. These risks also include such things as illness, injury, animal attack, severe weather, civil or political unrest, war, criminal activity or terrorism.
4. I hereby agree to waive and hold UIoBR absolutely harmless from any liability or legal responsibility of any kind whatsoever under the laws of the United States of America, the laws of the State of Connecticut or any other State, or the laws of any other country that may be alleged to apply, for any and all injury or loss that I sustain by way of bodily injury, illness, death, accusation of misappropriation or loss of my property that occurs during or in connection with this Venture from all risks that arise therefrom, including those risks specifically mentioned herein. I understand that by signing this agreement that I will not be able to recover any monetary compensation whatsoever from Urban Impact of Black Rock by way of suit or settlement for injuries or losses that are described herein. I also agree that if I or my estate were to bring suit against UIoBR seeking damages for any such injuries that I will indemnify and hold UIoBR absolutely harmless for all costs and expenses incurred by UIoBR in defense of such suit.
5. I hereby agree to indemnify and hold UIoBR absolutely harmless from any liability or loss whatsoever that may result to UIoBR, arising out of my participation in this Venture, including any actions on my part which are alleged to create a liability to any third person, including other participants in the Venture.
6. To the extent any portion of this Agreement is deemed invalid or in violation of public policy or law, the remainder of the Agreement shall remain in full force and effect.
